  - All work performed shall adhere to the standards set forth by the City of Batavia, the State of New York and the United States of America, ( e.g. : The Batavia Municipal Code - latest, Standard Specifications - N.Y.S.D.O.T. - latest, OSHA Construction Industry - **29 CFR 1926** ).
  - Sediment and Erosion controls shall be used, maintained and subject to warranty.
  - A COPY OF THIS PERMIT SHALL BE KEEP ONSITE. Upon request the permit shall be presented for inspection.

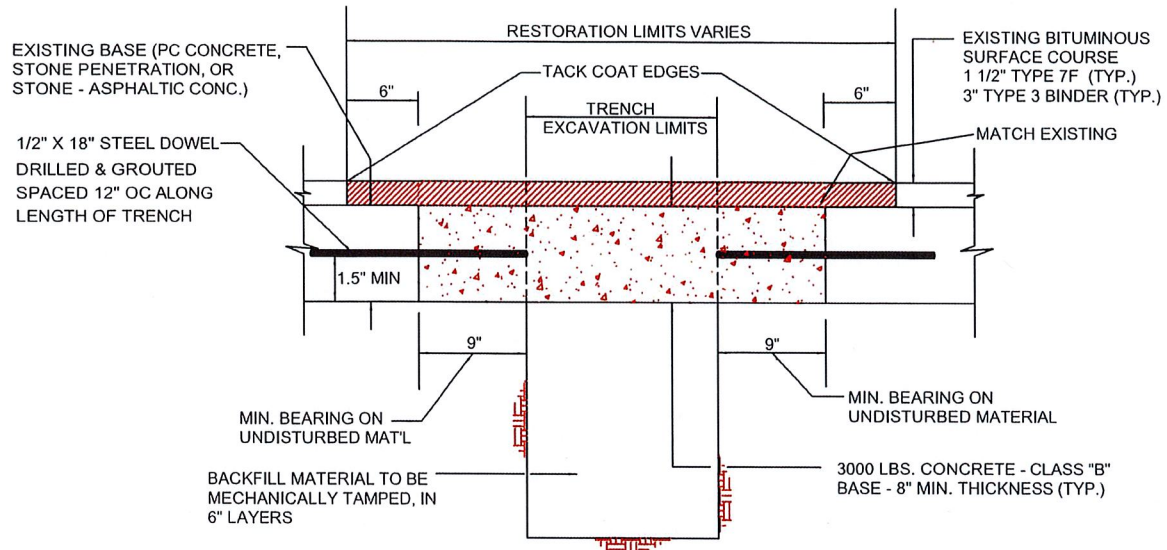

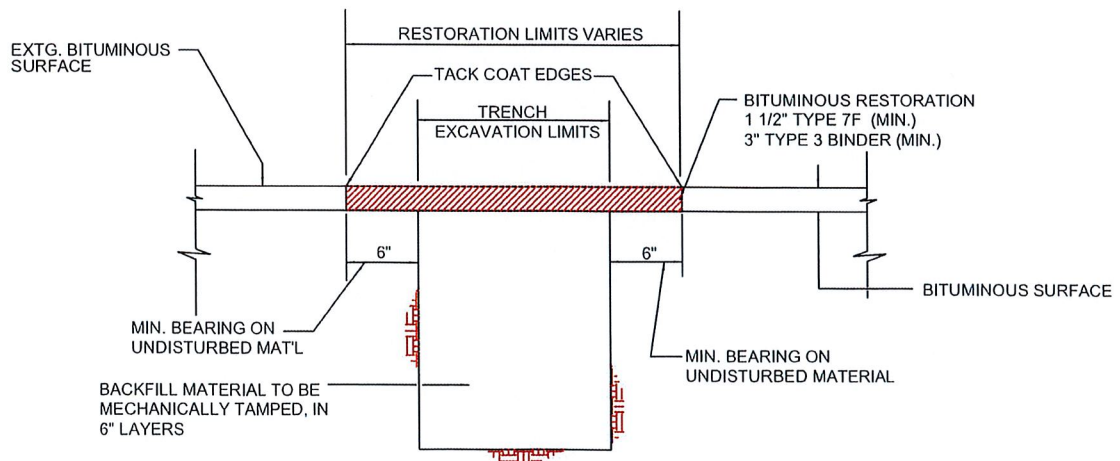

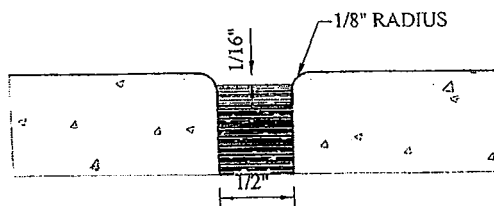
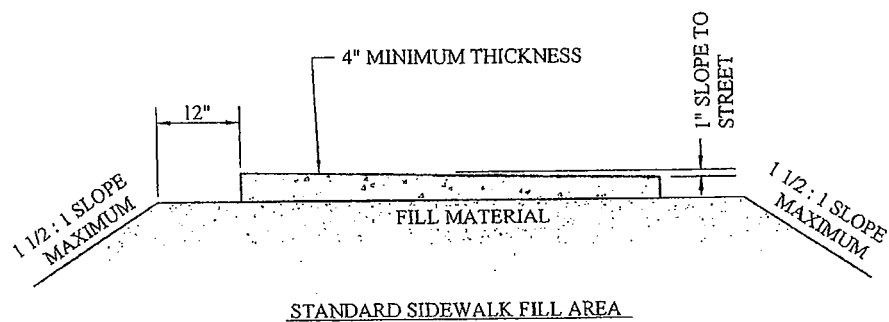

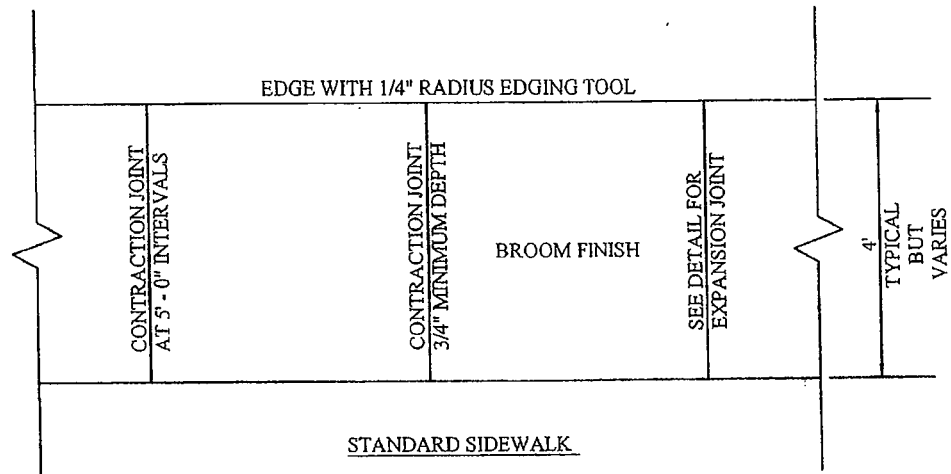
